

2021 Official Flip Flop to the World Ambassador CONTRACT

AGREEMENTS

1. The winner (Title Holder) shall adhere to the 2021 Official Flip Flop to the World Ambassador Rules and Regulations, in addition to those agreements set forth herein.

2. Title Holder Obligations and Responsibilities -

The Title Holder agrees to hold the respective Title, Flip Flop to the World, and Spruce Dickerson Foundation in the highest esteem, along with the following:

- To provide a satisfactory publicity photograph in crown and sash, within thirty (30) days of assuming the Title for use by Flip Flop to the World and Spruce Dickerson Foundation.
- To maintain contact with Flip Flop to the World during the year of her reign.
 - Promote the charity Flip Flop to the World by making appearances, having a flip flop collection or raising money for charity costs and shipping (either/or); and being the goodwill Ambassador spreading the wonderful news of Flip Flop to the World.
 - At least one promotional public appearance a month in regalia. A photo op is not considered an appearance.
 - >> Public Appearance is defined as any event in which Ambassador attends in full regalia in advocating for that cause, charity or organization, as well as, participating in an event.
 - >> Photo Op is defined as any picture that is taken in Ambassador's regalia in which it does not show participation in an event, or benefiting any cause or person.
- Photos of participation at every appearance are required.
- Appearances are not to support the alcohol, drug, or sex industry.
- Appearances will exclude bars, nightclubs and the nightlife scene, or anything that does not represent the mission, conduct, and image of Flip Flop to the World.
- Share ideas that could possibly further the growth of Flip Flop to the World.
- Be an active participant in the furthering of Flip Flop to the World.
- Maintain the Flip Flop to the World Ambassador Facebook page by posting appearance photos and engaging the community and supporters.

3. Title Holder Conduct, Rules and Regulations

- No drinking, drugging, cursing, inappropriate language, malicious gossip, lewd behavior, or any illegal activity while appearing, entertaining, or “representing the Title” during the year of your reign.
- Be always ladylike while appearing, entertaining, or “representing the Title” during the year of your reign.
- No arguing with anyone while representing Flip Flop to the World at an appearance. If there is a concern or a problem with anyone at an event, then inform the founder, Spruce Dickerson, and she will look into the matter.
- Have a heart for serving others.
- Have a lifestyle of graciousness.
- Promote goodwill in the community and across the world.
- No disparaging of Flip Flop to the World to anyone while appearing, entertaining, or “representing the Title” during the year of your reign. If the Ambassador has complaints, then they are to be discussed with the founder, Spruce Dickerson.
- If there are any concerns, questions, problems while reigning as the Ambassador of Flip Flop to the World, then inform the founder, Spruce Dickerson.
- Ambassador is allowed to keep her crown and sash, if she completes her one-year reign successfully.

4. Spruce Dickerson Foundation and Flip Flop to the World Remedies –

If the Title Holder defaults under this contract, Spruce Dickerson Foundation and Flip Flop to the World may treat any one or more of the foregoing occurrences as a breach of this contract and thereupon at its option may, without notice or demand of any kind (which Title Holder hereby expressly waives), invoke any or all of, but not limited to, the following remedies:

- a. Revoke the Title from the Title Holder.
- b. Demand the return of crown and sash, and any other prizes given to the Title Holder.
- c. Pass the Title to the 1st Runner-up or any other person felt to be qualified by Spruce Dickerson Foundation and Flip Flop to the World.
- d. Refuse bookings and appearances of an Official nature to Title Holder.

5. Release –

The Contestant agrees to release and hold harmless Spruce Dickerson Foundation and Flip Flop to the World and their committee members from any liability, and/or responsibility whatsoever, resulting from association with or arising out of Contestant's participation in the Flip Flop to the World Ambassador Competition, and/or the Title including, but not limited to, personal injury, or loss/damage to personal property during, or after the Flip Flop to the World Ambassador Competition, or any related activity. The Contestant also hereby releases herself from any and all rights to any videotaping (sound and/or video), photography, or motion picture of Flip Flop to the World Ambassador Competition or any related events. The Contestant also understands that they have or will have no rights to any of the recordings or photographs arising out of said contest that the Contestant may appear in or on. The Contestant will also have no rights to any proceeds from sales resulting from said recordings or photographs.

6. Spruce Dickerson Foundation and Flip Flop to the World reserves the right to make a decision concerning any matters not covered in the rules and regulations and the contestant agreement.
